### How does it work?

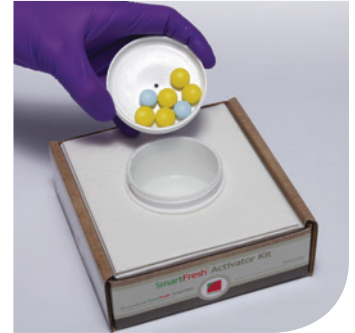
SmartFresh™ SmartTabs™ blocks ethylene receptors, extending the limes' shelf life and achieving longer green peel life.

### When is it applied?

Just after the harvest, in storage rooms, on the loading docks or on the go in shipment containers. It can be applied at any stage of the supply chain between the grower and retailer.

### Key benefits for limes:

- Extends green skin color for longer
- Increases shelf life while maintaining quality
- Maximizes flexibility for commercialization
- Reduces food waste and rejection



SmartFresh™ SmartTabs™ comes in tablet form and includes an application kit.

The intensity of the color can be measured objectively with the use of instruments such as colorimeters, in which hue-angle measurements with higher values show a more intense green color. In the graph, the fruits applied with SmartFresh™ show higher hue values throughout cold storage and commercialization than the control fruits without application, showing the effectiveness of SmartFresh to delay yellowing on limes.

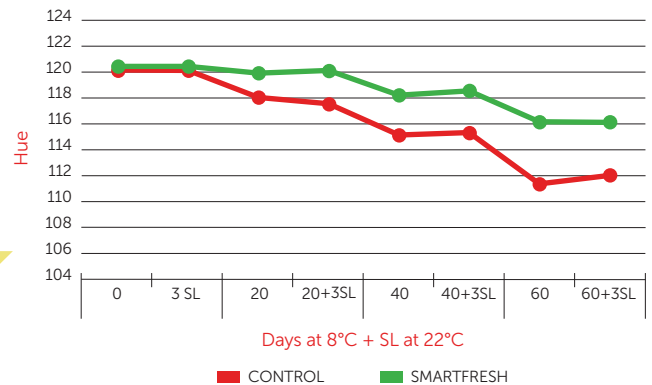
